## How you could benefit



#### MAKE BIG SAVINGS ON YOUR LOAN COSTS\*

The Australian Consumer and Competition Commission (ACCC) Home Loan Price Inquiry 2 in 2020 found that loyalty leads to higher loan costs and 94% of customers were paying 0.4% more than a customer taking out a new loan. The longer the customer has had the loan the more likely they would be paying more.



#### **ACCC HOME LOAN PRICE INQUIRY FINDINGS\***

The inquiry concluded that borrowers with home loans between:

- 3 and 5 years old were, on average, paying around 58 basis points <u>above</u> new loan rate
- 5 and 10 years old were, on average, paying around 71 basis points <u>above</u> new loan rate
- Greater than 10 years old were, on average, paying around 104 basis points <u>above</u> new loan rate.

### In simple terms, this is what it means in dollar savings.

Years since loan was established	3 to 5 years	5 to 10 years	Over 10 years
Interest above market	0.58%	0.71%	1.04%
Potential annual savings			
\$500,000 loan balance	\$2,900	\$3,550	\$5,200
\$750,000 loan balance	\$4,350	\$5,325	\$7,800
\$1,000,000 loan balance	\$5,800	\$7,100	\$10,400

### Case Study

Clients Kevin and Robynne have a home loan with a 2nd tier lender.

- They renegotiated their interest rate down in November 2019 to a very competitive interest rate but over the years the rate has risen. Their loan is on a variable rate, has an offset attached and redraw available.
- Their loan currently stands at \$377,984 and has 20 years to run.
- Their current interest rate stands at 5.57%.
- The best rate available to our brokers is 3.84%.
- On this reduced interest rate, the monthly repayment reduces by \$544.93 per month on a 20 year term.
- The saving is \$6,539.12 per annum and \$130,782.40 over the remaining term.
